FELONY COMPLAINT

The undersigned is informed and believes that:

COUNT 1

On or about November 6, 2006, in the County of Los Angeles, the crime of HAVING A CONCEALED FIREARM IN A VEHICLE, in violation of PENAL CODE SECTION 12025(a)(1), a Felony, was committed by MICAH SIERRA WILLIAMS, who did unlawfully carry concealed within a vehicle which was under his/her control and direction a pistol, revolver and firearm capable of being concealed upon the person.

It is further alleged that the firearm and unexpended ammunition were in the immediate possession of, and readily accessible to, the defendant and that the firearm was not registered to the defendant.

NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.
