Myoung Yi, of an address known to the District Attorney's Office, states as follows:

On August 27, 2004, at about 22:10 hours at 170 West 23rd Street in the County and State of New York, the Defendant committed the offenses of:

1. PL120.00(1) Assault in the Third Degree  
(2 counts)
2. PL120.00(2) Assault in the Third Degree  
(2 counts)
3. PL110/120.00(1) Attempted Assault in the Third Degree  
(2 counts)
4. PL240.26(1) Harassment in the Second degree  
(2 counts)

the defendant, with intent to cause physical injury to another person, caused such injury to another person; the defendant recklessly caused physical injury to another person; the defendant, with intent to cause physical injury to another person, attempted to cause such injury to another person; and the defendant, with intent to harass, annoy and alarm another, subjected that person to physical contact and attempted and threatened to do the same.


The offenses were committed under the following circumstances:

Deponent states that: (i) the defendant hit deponent about the body with a closed fist repeatedly; (ii) the defendant kicked deponent repeatedly; (iii) the defendant held a cellular telephone in defendant's closed hand and hit deponent in the face with said closed hand, causing the bottom of cellular telephone to hit deponent in the face; (iv) deponent fell to the ground and landed on deponent's hand as a result of said hit to the face; and, (v) the defendant's actions caused deponent to suffer injury, to wit, bruising and swelling to the face, bruised, swollen and immobile fingers, and substantial pain to the face and body.

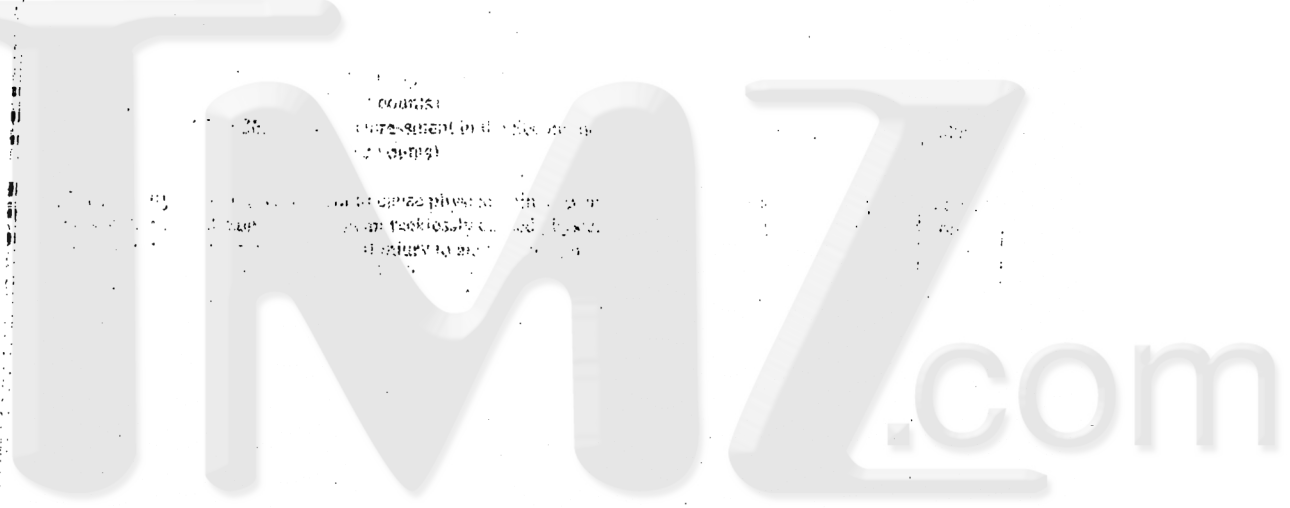
