ATTACHED). I THEN FORWARDED THE ORIGINAL S/GIBSON TO THE LABORATORY AND THE LABORATORY REPORT IS DATED OF 2/25/76 (N.D.G. DRUNK DRIVING).</p> <p>S/GIBSON WAS COOPERATIVE WITH THE FIELD INVESTIGATION HIS CONDUCT BEGAN TO CHANGE WHEN I ADVISED HIM HE WAS BEING DETAINED / ARRESTED FOR DRUNK DRIVING. S/GIBSON BECAME INCREASINGLY RESISTANT AS HE TOOK STOCK OF HIS PREDICAMENT. S/GIBSON ANGRILY STATED "OH MY GOD", "MY LIFE IS FINISHED." S/GIBSON'S CONDUCT REMAINED BEING

S/GIBSON HIMSELF CONTINUALLY THREATENED
SAYING, "I'M GOING TO FIVE YOU" AND WILL NEVER
BE HELD TO "GET EVEN" WITH ME. S/GIBSON
FOUNDED OUT A BARRAGE OF ANTI-SEMITIC
REMARKS ABOUT "FUCKING JEWS." S/GIBSON
TALKED OUT, "THE JEWS BARE RESPONSIBILITY FOR
ALL THE WAR IN THE WORLD." S/GIBSON THEN
ASKED, "ARE YOU A JEW?"

S/GIBSON'S CONDUCT CONCERNED AND FULMINATED
ME TO A POINT, I CALLED AHEAD TO THE
STATION REQUESTING A SERGEANT MEET THE
ARRIVAL OF MY PATROL CAR IN THE STATION PARKING
LOT. SGT. T. PALMER, # 264317 AND SGT. J.
GANNING, # 292797 MET WITH ME AS I HAD
REQUESTED. I BRIEFED THEM ABOUT S/GIBSON'S
CONDUCT BEFORE MEETING HIM AT THE STATION.
SGT. PALMER (SERV) LIVED TALKING S/GIBSON

TO CAPTURE ANY CONTINUED BELIEF IN CONVICTION, REEVE RV/2-3. SGT PALMER TAPE RECORDED THE CHEMICAL TEST, BREATH TEST, S/LOIBSON PERFORMED, IN THE BOOKING THAT FOLLOWED. S/LOIBSON DISPLAYED CONTINUED BELIEF IN CONVICTION AND GOOD WILLS, IN WHICH HE COOPERATED BY COMPLETING THE CHEMICAL TEST, BUT REFUSED TO PROVIDE BOOKING INFORMATION OR SIGN ANY DOCUMENTS.

I STORED S/LOIBSON'S VEHICLE PRIOR TO TRANSPORTING HIM TO THE STATION, PER 22651 (H.C.V. VEHICLE PARKING), REEVE 22651 (H.C.V. VEHICLE PARKING) NUMBERS. WHILE CONDUCTING AN INVENTORY SEARCH OF S/LOIBSON'S VEHICLE, I FOUND RV-1, A 750 ML BOTTLE LABELED "CAZADORA TRAVEL" THAT WAS APPROX. 3/4 FULL OF "LIQUID COFFEE". CONCEALED IN A BROWN PAPER BAG, ON THE RIGHT HAND SIDE OF THE VEHICLE (RV-1). PLACEMENT IN THE VEHICLE WAS WITHIN EASY REACH OF S/LOIBSON WHILE HE HAD BEEN DRIVING. S/LOIBSON MERELY HAD TO REACH OVER THE FRONT CENTER CONSOLE SEPARATING THE TWO FRONT SEATS.

I ASKED S/LOIBSON ABOUT THE BOTTLE. S/LOIBSON ASKED, "WAS IT IN A BROWN PAPER BAG?" WHEN I ANSWERED, "YES" S/LOIBSON QUICKLY REPLIED, "IT'S NOT MINE." I DETERMINED S/LOIBSON WAS DRIVING A VEHICLE (RV-1) OF AN OTHER PERSON'S DESIGN AND WAS
