We believe that we may have reached a full resolution of the custody and visitation issues and are in the process of preparing a formal judgment incorporating all of the terms thereof. We are jointly requesting that we be permitted to continue all matters currently scheduled for April 4, 2006 to a date approximately three weeks thereafter (i.e., (i.e., April 24 or April 19, 2006). We understand this is probably a shorter continuance than the court's calendar would ordinarily permit; however, we do not want to lose any momentum for settlement if the hearing date is continued too far out. Both sides are agreeable to all existing orders remaining in full force and effect pending the new hearing date.
