| <p><u>Source of Activity:</u></p> <p>On June 29, 2006 at approximately 2350 hrs, I Ofcr Truong #33512 was assigned to Hollywood Division front desk. Victim walked inside the police station and stated that he been assaulted by Woody Harelson the actor on the sitcom show "Cheers."</p> <p><u>Investigation:</u></p> <p>Victim (Joshua Levine) cameraman for AOL-WARNER BROS website TMZ. Victim stated that on the above date at approximately 2335 hrs, he was working as a cameraman for TMZ network and waiting for movie stars to arrive at a fashion premier located at the "Element Club on the N/E/C of Las Palmas and Hollywood Blvd. While waiting on the sidewalk with his camera, he obs'd the susp later identified as Woody Harelson exiting his vehicle. As the susp exited his veh, the vict attempted to film him with his hand held camera. While filming the susp, the susp approached the vict from the front and grabbed his camera with his right hand. The victim asked the susp to release his camera, stating, "Hey bro. let go of my camera." Suspect replied, "stop filming me," and broke the vict's camera viewfinder with his right hand. Once again, vict asked the susp to release his camera as he removed his compact digital camera from his left front pockets and took several photos of the susp holding on to his camera. Suspect then released the camera and grabbed the vict's neck with his right hand in an attempt to choke the vict. Victim was grasping for air when the vict's bodyguard pulled the susp away from him. Victim immediately drove to the Hollywood police station to report the incident. I Ofcr Truong notified Sgt Lawrence, Hollywood Division AWC and night watch Detective Conboy regarding the above incident. Ofcrs Havican and Lopez working 6X32 transported the vict to Cedars Sanai Hospital for medical treatment.</p> <p><u>Arrest:</u> None</p> <p><u>Booking:</u> None</p> <p><u>Medical Treatment and Injuries:</u> Ofcr obs'd the vict to have minor cuts to the vict neck.
